Know all by these presents, that the undersigned's hereby makes, constitutes and appoints Michael J. Blodnick and James H. Strosahl as the undersigned's true and lawful attorneys-in-fact, with full power and authority as hereinafter described on behalf of and in the name, place and stead of the undersigned to:
